Qualifications for the Offices of District Governor, First Vice District Governor & Second Vice District Governor

District Governor

A candidate shall:

- (a) Be an active member in good standing of a chartered Lions Club in good standing in his/her single or sub-district.
- (b) Secure the endorsement of his/her Club, or a majority of the Clubs in his/her single or sub-district.
- (c) Currently be serving as the 1st Vice District Governor within the District from which he/she is to be elected.
- (d) Only in the event that the current 1st Vice District Governor does not stand for election as District Governor, or if a vacancy in the position of 1st Vice District Governor exists at time of the District Convention, any club member who fulfils the qualifications for the office of 2nd Vice District Governor (as set out below) and who is currently serving or who has served one additional year as a member of the District Cabinet, shall fulfil the requirements of sub-section (c) of this section.

(International Constitution By-Laws – Article IX Section 4)

1st Vice District Governor

A candidate shall:

- (a) Be an active member in good standing of a chartered Lions Club in good standing in his / her single or sub-district.
- (b) Secure the endorsement of his/her Club, or a majority of the Clubs in his/her single or sub-district.
- (c) Currently be serving as the 2nd Vice District Governor within the District from which he/she is to be elected.
- (d) Only in the event that the current 2nd Vice District Governor does not stand for election as 1st Vice District Governor, or if a vacancy in the position of 2nd Vice District Governor exists at the time of the District Convention, any club member who fulfils the qualifications for the office of 2nd Vice District Governor as set forth, shall fulfil the requirements of subsection (c) above.

2nd Vice District Governor

A candidate shall:

- (1) Be an active member in good standing of a chartered Lions Club in good standing in his/her single or sub- district.
- (2) Secure the endorsement of his/her club or of a majority of the clubs in his/her single or sub-district.
- (3) Have served or will have served at the time he/she takes office as 2nd Vice District Governor :
 - (a) As President of a Lions Club for a full term or a major portion thereof, and a member of the board of directors of a Lions Club for no less than two additional years: and
 - (b) As zone chairman, or Cabinet Secretary or Cabinet Treasurer for a full term or major portion thereof.
 - (c) With none of the above being served concurrently.

(International Constitution By-Laws – Article IX Section 6)
